

Call of the Horse Equine Art Show

ARTWORK ELIGIBILITY

- Art Categories: Painting, drawing, illustration, printmaking, photography, digital art, sculpture and mixed media are accepted.
- Style: All styles are welcome.
- Size: Please limit pieces to no greater than 24x36 inches. At this time, North Dakota Equine Association is requesting artists choosing to participate in the 2021 Art show provide their own fixtures to help us exhibit artwork if possible.
- Number of Artworks: Artists are invited to submit up to 3 pieces of their original artworks.
- Fee: \$15 non-refundable per entry
- Originality and Rights:
 - Artists should own all the rights for promoting, publishing and selling the artworks locally and internationally.
 - - Entries must not be copies or derivatives based, in any way, on other copyrighted or published paintings, photographs, sculptures, or other artistic works.
 - - Organizers have the rights to use artworks and artists data for promoting the exhibition.
- Please use plexiglass where possible to avoid shipping damages.

LIABILITY

North Dakota Equine Association will not be liable for any loss, theft, damage or deterioration of artwork before, during, or after the show.

- Participating artists assume responsibility for their property and their personal safety.
- Insurance coverage for Artists' property is the responsibility of the Artist.
- Artists are responsible for adhering to copyright laws that may pertain to their work.

MEDIA RELEASE

North Dakota Equine Association may use Artist's Name, biographical information as submitted by the artist, and images of their artwork for the sole purpose of promoting the exhibition.

This information will be used for online and print publications, social and broadcast media, and marketing materials including postcards and flyers. Artists release North Dakota Equine Association from any liability resulting from the use of this information.

Photos of the opening reception, exhibit (possibly including artist & artwork) may be used to promote current and future shows.

All artwork must be original. Prints are allowed only if this is common practice for the media. In other words, photography or lithograph prints are acceptable.

Accepted work must be available for the entire exhibition period.

SALES

All work submitted must be for sale and is subject to a 30% commission. Be sure your price reflects the commission. NDEA uses the price you submit upon application and that is the price that will be used for the exhibition.

Artists should adjust prices accordingly and cannot change price after submission. Any artwork exhibited or commissioned work sold within 60 days of the art show close is subject to a 30% sales commission to the North Dakota Equine Association. Artists may only sell artwork accepted for the art show on the Expo premises except for special commissioned pieces. NDEA will handle transactions for the artist with regular 30% commission. Accepted artwork must remain on exhibit until the art show closes.

Hand Delivery/Pick-Up of Accepted Work:

Hand-delivered artwork must arrive during setup day Thursday June 3rd 2021.

Hand-delivered unsold artwork pick-up is Sunday June 6th. Please notify NDEA via email at ndea.marketing@gmail.com of any last-minute pick-up changes or to allow another representative to pick-up your work.

Shipping of Accepted Work/Return Shipping:

All shipped artwork MUST include preprinted return shipping labels with barcodes for every box delivered. If the artist does not provide a return shipping label by June 3rd, 2021, their work will not be included in the show, and NDEA will return their artwork C.O.D using a carrier of NDEA's choice. Plan on your work arriving the week of May 24th – May 28th, 2021.

Artwork not received by June 1st 2021 may not be included in the show.

Artists are responsible for additional shipping costs due to refused or returned artwork.

NDEA strongly recommends shipping all artwork through FedEx. Artists can preprint return labels online through FedEx's website.

Packing Artwork

No packing peanuts allowed. Artists shipping with packing peanuts will have a \$50 repacking penalty. NDEA will ship artwork not picked up personally back with packing materials provided by the artist. Artists who do not provide adequate packing materials will pay a flat \$20 fee for new packing material.

NDEA will take the greatest care in handling all work. The artist is responsible for insuring work to and from the show.

Works not picked up or returned by June 15, 2021 will become the property of the NDEA.

Submission of an entry to this exhibition constitutes agreement on the part of the entrant to these conditions. NDEA reserves the right to reject any works not properly presented or ready for exhibition in a gallery.
